## 1. What kinds of special needs are catered for at Tankersley St Peter's CE Primary School?

The school supports learners with a wide range of SEN needs and disabilities, which include Cognition and Learning, Speech, Language and Communication, Specific Learning difficulties such as Dyslexia and DCD (Developmental Co-ordination Disorder), Social, Communication and Interaction challenges, including Autism, Social, Emotional and Mental Health difficulties, Hearing Impairment, Visual Impairment, Physical Disability and a wide range of Medical needs. There are many needs that we are able to cater for and we would welcome you to contact us if you require further information.

## 2. How are special needs identified?

Our aim is to identify special needs as early as possible when children enter school and our Early Years Team are skilled in identifying children who have difficulties with their learning or speech and social communication. Early intervention is the key in achieving successful outcomes for children and their families. The school follows the SEND Code of Practice 2015: 0 to 25 years Graduated Approach with regard to the Identification, Assessment and Review of children with Special Educational Needs. This is a whole school approach.



Initially, children's needs are identified by the class teacher / Key Stage Co-Ordinator, or in conjunction with parents and pre-school/Nursery settings. The SENCO is involved in these discussions and partnership with parents is highly valued in order to ensure the best outcomes are achieved for the child. The child will then be monitored both informally and through termly Pupil Progress Meetings. Three SEN review meetings are held to review process. A child with an Educational Health Care Plan (EHCP) will also have three review meetings a year, one of which is their EHCP Annual Review meeting. An Entry to Send document is agreed upon with parents, who are offered a booklet entitled: 'Children with Special Educational Needs and Disability (SEND).' A Booklet for Parents and Carers.' A unique School Support Plan (SSP) is set up for the child, which details strengths and challenges that the pupil may have. It also details the targets and

provision that are in place. The SSP considers barriers to learning and the actions that will be taken to address them. This could include extra support in class, additional resource use and / or adaptations to the teaching or environment. Short term interventions are used to close the gap in attainment by accelerating a child's progress.

### **3. What are the school's partnerships with external services?**

The school works very closely with a wide range of services such as the Early Years Inclusion Service, the Educational Psychology Service, Speech and Language Therapy Service, the Social Communication and Interaction team plus the School Nurse, Family Support Workers and Health Visitors. School also works with CAMHS (Children and Adolescent Mental Health Service), Compass Be, Branching Minds and the Social Care team. These services then fully assess pupils following a referral, after parental consent has been gained. Extending our school approach, we collaborate and work using an outcomes-based approach. This enables us to hold our partners and ourselves to account. We believe that this has benefited our children /young people and their families in the following ways:

- Parents work in co-production with school and are kept up to date with developments and practice
- Pupils feel valued and are very much part of the school community
- Pupil outcomes and progress are strong

Other links to support SEND in school include the Local Authority SEND Team. We have active involvement with our Send Participation officer and Child voice participation officer across the year and our SENCO attends locality network meetings with other SENCO's. Our SENCO also attends courses provided externally and the annual SEND conference as well as the Autumn, Spring and Summer SEND forums. Extra specific SEND training is also accessed by all staff on The National College. This year the SENCO is continuing to work in partnership with our school's SEND Participation and SEND Improvement Officer to embed the authority wide PINS project which focuses on meeting the needs of all Neurodiverse pupils in our schools. Our SENCO is also leading the school in achieving the Charter Mark for being a Barnsley Autism Friendly School. Our SENCO and Headteacher are also involved in a number of Child Voice Summits in the Barnsley Authority, giving the childrens' perspectives and helping to shape provision in Barnsley for children with Special Educational Needs. Our Tankersley School Inclusion Working Party met twice last year and will meet three times this year. The members include pupils with SEND, our SEND Governor, Reverend Chris, Mrs Harrison, another teacher representative and a few parents of children with SEND in school. The aim of the working party is to assess and adjust the effectiveness of our Anti-Bullying and SEND policies, using the lived experiences of pupils and other stakeholders to ensure full inclusion and equity for our pupils with SEND. Another aim is to increase the whole school community awareness and understanding of a range of special needs and disabilities.

### **4. How are parents involved?**

Communication with parents happens in a variety of ways such as face to face conversations, in school or remote meetings, letters, e mails, and phone calls. We have a SEND section on the school website with our SEND Mission Statement, along with other information for parents. This includes the school Local Offer, the SEND Policy plus a range of other related policies. It also signposts parents to further advice and support agencies as part of the Barnsley Council Virtual Family Hub resources and information . As well as this, our SENCO/Early Years Co-ordinator also leads Early Help Assessments with regular Team Around the Family (TAF) meetings, to support with family and/or SEN challenges. Having our SENCO based in Reception class ensures Early Intervention to create best outcomes for our pupils. A unique Early Help Action Plan is created along with targets, which are reviewed regularly. Again, the appropriate services

and professionals are involved.

For children on the SEND Register, regular termly reviews with the Class teacher, SENCO and appropriate outside professionals are carried out. These occur 3 times a year to discuss children's individual needs, outcomes, targets and the provisions in place. Parents are invited to attend these reviews, by attending meetings in school or remotely. Copies of reviewed and updated paperwork are sent home to parents.

Children with high or complex needs may have Education, Health and Care Plans which are applied for with parental partnership. These are reviewed annually as well as two more SEND review meetings. A child with an EHCP has an EHCP monitoring plan instead of a School Support Plan, which details outcomes, short term targets and provisions from the child's EHCP document and feeds into the Annual Review.

As well as the above systems in place, school staff are continually reviewing a child's SSP or EHCP monitoring plan targets and progress, making annotations on the plans in order to swiftly move the child's learning on and to maximise their progress.

All parents of children with SEND are invited to a termly coffee and cake afternoon along with the SENCO and often with our Parent Voice SEND Participation officer and SEND Improvement Officer from the LEA, to offer sign posting and to capture parent voices in order to further improve SEND services and support. The coffee afternoon is an informal get together and support network. It is also often attended by our school's Mental Health practitioner from Compass Be.

All children have the opportunity to speak to teachers and teaching assistants on a daily basis and each class also has a Worry Monster where children know they can draw or write to express a worry that a staff member will speak with them about on a 1:1 basis. The children also have opportunities to carry out a range of school jobs. We work closely with our Compass Mental Health Practitioner, who is actively supporting pupils and their families, offering 1:1 support where needed and even class workshops.

Pupils can access Nurture/Inclusion staff and wellbeing groups where they can talk about any difficulties or worries. More details can be found in 'Our Graduated Response to Social, Emotional, Mental Health and Wellbeing' document on the SEND area of the school website. We also seek the views and opinions of children via the School Core Council, Worship Council and Inclusion working party. Children's views are sought regularly and prior to each SEND Review. A One Page Profile Document is also part of the child's SSP and it records likes, interests, aspirations and ways that others can support them.

## **5. What are the arrangements for assessing and reviewing progress and what opportunities are there for working with parents and children?**

The school follows the SEND Code of Practice 2015: 0 to 25 years Graduated Approach with regard to the Identification, Assessment and Review of children with Special Educational Needs. The four key actions are:

**Assess:** A range of assessment strategies are used in school including the national baseline and other Foundation Stage Assessments, Teacher assessments, SATS results, Y1 phonics test scores. Tracking systems used to input assessments include O Track and B Squared (V 5 Connecting Steps). The V5 Connecting Steps is used to provide some of our children with extra small next steps in the main curriculum areas. These can be used to inform the child's SSP smart targets and provide detailed progress information. Children who are not making expected progress are discussed at Pupil Progress Meetings and an action plan is created to help close attainment gaps, by accelerating progress. The Class Teacher, Key Stage Co-Ordinator and SENCO analyses a child's needs and any barriers to learning. This is in partnership with the child's parents. Sometimes, an assessment by an outside professional, such as the Speech and Language Therapist, may be carried out. An Early Years Development tool is also used to track some childrens' progress if needed.

**Plan:** Where a SEND need is identified, an outcome-focused plan is developed, making sure that the child

and their holistic needs are at the centre along with their own ideas and views. The Class Teacher will discuss with parents that their child requires additional support and provision.

**Do:** The agreed plan developed in response to the assessment process is implemented. The Class Teacher works closely with the Headteacher, Key Stage Co-ordinator and SENCO to plan and assess interventions put in place.

**Review:** Regular reviews take place to discuss outcomes for each child. Progress against outcomes is evaluated to determine the effectiveness of the support provided. The review will question what is working well, what the barriers to learning are and what needs to change. Impact will be evaluated along with next steps.

Parents and children are asked to contribute throughout the above stages. We are proactive in seeking out their opinions and views, so that provision and outcomes are child and family-centered.

Children's progress is also reviewed at Pupil Progress Meetings which take place at the end of each term. These meetings are attended by the Headteacher and Class teacher. Required support and interventions are identified and agreed for pupils making less than expected progress.

The SENCO creates SEND reports for Governors. Parents are also involved with their children's learning in many ways, such as attending RWInc, Maths Mastery, Lets Get Moving (Physical Development), Playdough Disco workshops and Reading afternoons as well as attending trips.

## **6. What are the arrangements for supporting transition?**

Robust transition arrangements are in place for any points of transition.

### **Year 6-Year 7**

A transition co-production discussion group is held every Autumn and Year 5 and 6 parents of pupils on the SEN register are invited into school with the SENCO to talk about their feelings, ideas and opinions in relation to their child's transition to Year 7. The children will also complete a high school transition booklet.

Responsibility for the high school transition for children on the SEND register lies with the SENCO.

Professionals from High schools visit the children in their current school and the SENCO arranges and attends extra visits to different feeder high schools along with children and their families. The SENCO also contacts High school SENCOs to share information and all SEND files are securely passed on via CPOMS to the different feeder schools, prior to the children starting.

### **FS2**

Melanie Hartley (Reception class teacher, Early Years Co-ordinator and SENCO) will conduct a home and/or Nursery visit to children and families who are new to our Early Years setting. A discussion is held with the child's keyworker regarding interests, strengths, progress and attainment, as well as any areas needing specific strategies and /or provision. Transition days are organised in school for children to visit Foundation Stage prior to starting in September. Parents are also invited into school to attend a parent information session, prior to their child's school transition visits.

### **Transition between year groups**

Children take part in transition visits to their new classes. Photographic newsletters/social stories are created for pupils on the SEN register towards the end of the school year. These allow the children to share their new class photographs and information with family and friends at home over the summer holidays, to increase their confidence and wellbeing before the new school year starts.

### **Moving to Tankersley St Peter's CE Primary school from a different school**

When a child moves to our school, from a different primary school, an initial meeting is held with parents, the child and any other linked professionals prior to the start date. On the day the child starts

school, they will be greeted by the Class teacher and TA who will arrange a ‘buddy’ to support settling in. Regular check ins will be made with the child to ensure that they feel happy and welcomed, to maximise their participation and belonging.

If children allocated a place at Tankersley St Peter’s CE Primary school are already on their previous school’s SEND Register, our SENCO will contact the SENCO or class teacher at the previous setting to gather information about the child. All relevant paperwork is passed on from the previous school to the SENCO. As soon as a child with an identified SEND need starts at school, a file is created for them and relevant information is shared with the class teacher.

## **7. What is the approach to teaching children with SEND, and how are adaptations made to the curriculum and learning environment?**

The SENCO, Headteacher and Senior Leaders are responsible for overseeing the provision and interventions for all SEND learners.

Class teachers are responsible for Quality First Teaching and planning lessons which cater for all learners in their class. Children have access to a differentiated, broad and balanced curriculum with a focus on their needs and on removing barriers to learning. This is supported by Teaching Assistants and Education keyworkers who support children with EHCP’s.

The school also supports children by providing specialist equipment, such as ear defenders, writing aids, visual resources including word mats, widget picture/symbol/print visual timetables, end of day review charts, celebration books, home/school communication books, individual work-stations, emotions fans, fidget toys and sensory boxes for example. Teachers are also aware of different teaching styles that may be employed and can use a variety of approaches, such as multi-sensory learning and movement breaks. It is at the school's discretion to adapt or change the routine for SEND learners, in partnership with parents. This year's SEND next steps will continue to focus upon the SENCO's coaching model; working within classrooms alongside children and staff to closely evaluate provision and ensure accurate pitch of the pupils' work and learning, in order to further enhance their independence, high engagement, self-esteem and learning outcomes.

## **8. What is the expertise of staff and what training have they had?**

At Tankersley St Peter’s CE Primary school, we feel it is important to source and find the best possible training available for all staff. Training is ongoing in order to maintain and update skills and keep abreast with new initiatives. The SENCO (Melanie Hartley) has achieved the Post Graduate Qualification for Special Educational Needs Co-ordination and has increased SEND expertise capacity in EYFS and both Key Stage 1, Key Stage 2 through developing staff SEND Champions. The Headteacher (Vicky Harrison) also holds the NASENCO Post Graduate award. Both staff members hold SEND training linked to therapeutic language, mental health and wellbeing, Autism ADHD, Downs Syndrome, Dyslexia and a range of other specific learning difficulties.

We have staff trained and able to deliver support for speech and language interventions, nurture/well-being and mental health-based activities, emotion coaching, gross and fine motor activities, dyslexia, social and communication skills, including Makaton, precision teaching and support for medical needs. If a specific need arises that we may have not supported before, we will work with other services to source appropriate training.

At varying times across the school year, we have staff delivering interventions including:

**A daily sensory circuit in the school hall** to support physical skills, co-ordination and sensory needs as well

as encouraging positive engagement, motivation and behaviours.

**Speech and language interventions** – The programmes are recommended by the Speech and Language Service following assessment and include support to develop expressive and receptive language, along with strategies to support stammers

**Wellcomm and Elklan**-early language and interaction interventions

**Bucket Time**-1:1 Attention Autism intervention to encourage use of eye contact and engagement

**Music Interaction**-A small group intervention to encourage engagement, active listening and taking turns

**Time to Talk**-A small group intervention to encourage understanding, confidence and extended talk

**Kagan structures and Talking Partners** to encourage social skills and turn taking

**Precision teaching**-To help children with their sight vocabulary knowledge, to apply to both reading and writing

**Launchpad for Literacy**- an approach to identify gaps in any strand of literacy learning and address next steps in EYFS onwards

**Project X**- 1:1 reading fluency and comprehension skills support

**RWInc catch up**-1:1 recapping of recognising letters and special friends

**Fresh Start/RWInc**-upper Key Stage 2 1:1 reading catch up

**Same day interventions**-pre and post teaching **Pre-teach vocabulary sent home**-children with SEND have the focus vocabulary for the following half term, sent home to practice before using it in class

**NeuroBears** programme-to aid a group of children in KS 2 with understanding and developing strategies relating to their autism diagnosis

**Gross and Fine motor skills** – including the delivery of individual packages set by a Physiotherapists and Occupational Therapists- handwriting practice, manipulation of small objects and exercises to improve strength and coordination, scissor skills, use of touch typing on a laptop and Google Chrome to support a child with recording their learning. **Write from the Start**-to develop muscles in the hand, hand/eye co-ordination, spatial organisation and handwriting skills

**Booster groups** with Maths and Literacy foci

**Job Shop**-Children having chance to apply and do different jobs around school e.g. EYFS assistant, Office assistant, Digital Leader

**Emotional Literacy** supporting pupils who need support with strategies to regulate and understand theirs and other people's emotions and **Social Skills for kids (SCI team/CAMHS programme for use in school)**

**Nurture groups** covering nurture principles for EYFS 'Stay and Play' club, KS1 (Knitter Natter) and KS1 and 2 small group baking nurture when needed. Teaching assistants also run a range of lunch time clubs for our pupils with SEND, focusing on social skills such as turn taking, expressing ideas and emotions

**Nurture 1:1**-Staff members working with pupils 1:1 to support well-being and mental health

**Compass Mental Health Practitioner**- works alongside identified pupils and families in school

**Personal timetables**-Some children with EHCP's have tailored timetables linked to their EHCP targets and outcomes

**Active Literacy**- to support pupils with dyslexic tendencies who need a different approach to reading and spelling

**See and Learn**-to support some children with early language use, vocabulary and phonics/reading

Staff have had therapeutic language training and some staff have had Trauma Informed and Low Mood training. Key members of staff have been trained with Team Teach to de-escalate pupil behaviours if needed and apply positive handing techniques, as a graduated approach. They are designed to minimise risk and help people maintain positive relationships. Part of a staff member's duty of care may involve needing to physically intervene in an emergency. Future training includes refreshment of therapeutic language and Team Teach. Compass Be have also delivered whole school staff training on 'Supporting Children's' Anxieties' and on 'Staff Wellbeing.' We have a number of staff trained in Paediatric first aid who are responsible for administering medication to pupils e.g. inhalers. Whole school training has taken place on Autism Awareness Parts 1 and 2 with Lora Moore (SCI consultant) and more recently Melanie Booth (SCI team) has delivered some preliminary training and given out classroom audits for staff to complete, to work towards the Barnsley Autism Friendly Status in the future. TA's had 'The Use Of Visuals' training from the SCI team last year and Teachers had 'Emotional Regulation' training also delivered by the sci team last year. There has been attachment training, Stammer training for staff who need it to support particular pupils. Staff have their own log ins to The National College so that they can access training about all developments and practice relating to SEND pupils and other training across the curriculum. The SENCO (M.H) attends the annual Barnsley SEND Conference along with Barnsley Locality meetings and termly Barnsley SEND Forums. This year we are having whole school staff training on Executive Functioning with our link Educational Psychologist.

## **9. How do we evaluate the effectiveness of the provision made for children with SEND?**

The progress of all pupils is monitored regularly and more formally at the end of each term. This information is shared at Pupil Progress Meetings and all pupils who are not at Age Related Expectation or are not making sufficient progress, are identified. Next steps for strategies, adaptations to teaching and environment plus interventions are agreed upon. Many children are assessed against the year group expectations but some are assessed and monitored using Connecting Steps V5, to show small steps of progress. Where progress falls below that is expected, we adjust provision accordingly to ensure children have the best possible opportunities to fulfil their potential, increasing their equitable experience. The whole school SEND Reviews by Barnsley Council's SEND Improvement Services have been positive experiences. They have highlighted strong SEND practices across our school with all previous next steps actioned and implemented effectively. This year's next steps include achieving Barnsley Autism Friendly status, continuing to quality assure all of our SMART targets on School Support Plans and continuing to run the Inclusion working party and Child Voice activities.

## **10. How are children with SEND enabled to fully participate in school life?**

The school is committed to providing equal opportunities for all and equity, regardless of race, faith, gender, or capability, in all aspects of school life. We promote self and mutual respect and a caring and non-judgmental, inclusive attitude throughout school. We aim to include all learners on school trips, residential visits and after school clubs. Planning for this is in partnership with parents and reasonable adjustments are made where appropriate, in order for all children to access these opportunities. A trained first aider attends all visits and can administer medication where necessary. Sometimes, parents may be invited to accompany their child on a day trip as part of a reasonable adjustment. Pupils with SEND are encouraged to apply for the Job Shop jobs across school to increase their inclusion, self-confidence, self-esteem, social skills and responsibility.

## **11. What support is there for improving social and emotional development?**

Melanie Hartley is our Early Help practitioner and our Mental Health Leads in school are Mrs. Harrison and Mrs. Hartley. All staff members across school are involved in providing nurture and mental Health support and can offer children a home wellbeing and mental health pack to work on as part of the universal offer. Children's social and emotional development features highly in our whole school PHSCE curriculum, where

we use our '1 Decision' scheme to support children's' holistic development. Nurture groups across school support children when needed and we have a 1:1 Compass Be mental health practitioner support if needed. Compass Be also attend our parent workshops on PHSCE, Mental Health and Social Media/Internet Safety, offering support to families. Compass Be, Vicky Harrison and Melanie Hartley have worked together to develop some pupil and parent support sessions. Areas of support for pupils and families include internet/social media safety, self-esteem, social skills, bereavement, anger management, friendship difficulties and behaviour management. In school, children are given the opportunity to discuss their feelings and are supported with strategies and advice that might help. Sometimes individual positive behaviour plans are created for children who need them, in partnership with parents. The strategies and therapeutic language use contained within them can be used at home and school. These plans sometimes include strategies for supporting the child with de-escalation and recovery strategies.

In EYFS there is a weekly 'Stay and Play' Nurture lunch time club, which is a small child led F1 and 2 club, where social skills, confidence and self-esteem can be developed through relaxed play and interaction. It is run by M. Hartley and C. Terrell, providing support in a safe and specially adapted environment for our children who have social, emotional and learning needs. There is a strong focus within the group on social and life skills where children are supported in understanding their feelings and the feelings of others. In Key Stage 1, there is a Knitter Natter wellbeing club, run by S. Pitwell and the children are engaged in craft/hobby activities whilst having the space to chat and express themselves in a nurturing environment. The KS1 and 2 groups work upon social and interaction strategies, regulation and nurture in the board game and baking sessions. Our lunch time clubs include lego and game playing, which support childrens' regulation and relaxation.

## **12. How do we involve other services in meeting children's SEND?**

Excellent relationships and very close working partnerships have been established with a number of external agencies including the Early years Inclusion team, Speech and Language Therapy, the Social Communication and Interaction Team, the Educational Psychology Service plus Health Visitors, the school nurse, Early Years Development practitioners, Family Support Workers and Occupational Therapy plus Physiotherapy teams.

Advice is sought from agencies and referrals made in agreement with parents, when needed. These external agencies support school staff in identifying a child's barriers to learning and they provide advice for both school staff and parents. The work undertaken to engage such services in school is coordinated by the SENCO.

## **13. How do we support Looked After or previously Looked After Children (LAC)?**

School staff closely monitor the emotional well-being and presentation of LAC while in school. Learning and progress is monitored in line with school systems and information is shared by the Headteacher or SENCO at any review meetings. School liaises closely with foster carers, social workers and the Local Authority in making sure that children get the best possible outcomes. The views of children are always sought and shared at all meetings and where appropriate the child or child's advocate attends the meetings.

## **14. What were the Covid challenges?**

In terms of the Corona Virus pandemic: wherever possible and where the child's SEN needs have allowed, SEND children attended school during lockdown and accessed daily remote lessons from the class teacher as well as full days of lessons in class with TA's in smaller groups. The Purple Mash computer learning platform was used for children accessing learning from home and this was regularly marked with positive feedback and next steps to work on. Alongside this, many members of staff made telephone calls to parents and children to check in with them and support in any way possible. Provision was also made for pupils who needed computers and those children who preferred to have paper copy work packs. On arrival back into school after time at home, the SENCO created risk assessments for children who would

potentially find the re-adjustment challenging, in partnership with parents and class teachers. Also, a lock down parent SSP review questionnaires were sent home to the parents of children on the SEND register, which detailed parent's views and their child's progress and experiences whilst receiving home learning. The SENCO was also regularly in touch with parents of SEN pupils via telephone and e mail. Remote SSP meetings also proved to be effective ways of continuing to review with parents during the pandemic.

**Other challenges for our school, some as a result of past Covid times and some not, have included:**

- Increasing numbers of high needs SEND pupils
- Increasing needs relating to Social, Emotional and Mental Health plus Speech and Language
- Meeting the above needs with no increase in High Needs block funding

**We are addressing the above by:**

- Seeking external support and advice, working co-productively
- Enhancing our current SEND provision and sharing good practice in our locality of schools
- Securing EHCP's for our most complex SEND pupils to ensure outcomes/provisions are appropriate for their needs
- The SENCO employing the coaching strategy to work alongside staff and children with SEND to ensure accurate pitch of learning and to facilitate pupil independence, motivation and resilience
- Working in co-production with parents to ensure positive outcomes for all pupils
- Developing SEND team capacity by having EYFS, KS1 and KS 2 SEND Champions working alongside all staff, the SENCO and Head teacher

**15. How are staff deployed?**

Considerable thought, planning and preparation goes into utilising our support staff to ensure children achieve the best outcomes, gain independence and are prepared for adulthood from the earliest possible age. Support staff are deployed to classes on the basis of pupil need. Children who have EHCP's will receive some additional support in class to ensure outcomes and provision are in place. EHCP's are maintained and applied for in line with Local Authority advice. The Barnsley EHCP hub is used for applications and annual reviews of EHCP's as well as the Sheffield and Huddersfield LEA procedures when appropriate. Children with high and complex needs are supported through this process and are in receipt of High Needs Funding (Range Funding). EHCP Annual Reviews ensure that the provision and needs accurately reflect the pupil presentation in school. Parental partnership and co-production, along with pupil voice are crucial in the application process, review and maintenance of EHCP's. We work collaboratively with outside agencies also to ensure the best possible outcomes for pupils who require or have EHCP's. Our SEND Budget shows our commitment to Inclusion and provision for all pupils.

Our strategic plans for developing and enhancing SEND provision in our school for 2025-2026 includes:

- Continue to Quality assure SMART targets in Support plans
- Raising the aspirations of children with SEND, making explicit links to careers based on childrens' own interests
- Submit portfolio to achieve the Barnsley Autism Friendly Schools Charter
- Share and embed good practice of curriculum adaptations across school
- Continue to be involved in the Primary Voice group in Barnsley Authority to give our pupils with SEND the opportunity to express their ideas and views with other pupils across the authority, based upon their lived experiences, to help shape SEND provision across the authority
- Embedding the Inclusion Working Party practices in school, with all stakeholders represented, to guide our progress and accountability in areas of SEND, Mental Health and Wellbeing, PHSCE, Parental Partnership, Children's' voices and Anti-Bullying, ensuring that we can continually adapt and meet the needs of the community that we serve. Continue to work closely with our Compass Be Mental Health Practitioner who is actively supporting pupils and their families.
- Develop training around SEND for dinner time staff
- Continue to sign post the support of the Family Hubs
